ABOUT THE MANUFACTURER

PRODUCT DESCRIPTION

PTM DuraFlex Kombi is used as the bottom layer in multi-layer roofing in new roofing and renovation projects, where the top layer is welded on. The product is advantageously used in projects that must be carried out at low working temperatures, or where movements in the substrate may occur. PTM DuraFlex Kombi is also used in renovation projects where there is a particularly high water load and where there is no possibility of complete roof drainage. PTM DuraFlex Kombi is primarily mechanically fastened to the substrate, but can also be fully welded or spot welded in case of renovation projects. The product is a polymer membrane with polyester/glass felt reinforcement that is impregnated with bitumen. It is then coated on the top and bottom with SBS polymer bitumen.

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

The manufacturing is done by heating the raw materials (bitumen and polymers) to a specific temperature and mixing them. The bitumen is generally delivered hot from the petroleum refinery to the manufacturing site, where it's heated further. After this the mix is applied to the reinforcing structure (polyester/glass reinforcement). The resulting sheet is cooled and then faced with slate on the upper side and PP film on the bottom side. The resulting sheet is then rolled and cut to desired length. Eventually the product is loaded onto trucks and transported to a construction site. The emission data for bitumen is based on The Eurobitume Life Cycle Assessment 4.0 for bitumen, published March, 2025.

The use of green energy in manufacturing is demonstrated through contractual instruments (GOs, RECs, etc.), and its use is ensured throughout the validity period of this EPD.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

Average distance of transportation from production plant to building site is assumed as 170 km in average in DK, and the transportation method is by lorry. Transportation does not cause losses as products are packaged properly. Packaging treatment was considered in module A5, with scenarios for wood and plastics as per Eurostat.

Installation is done by mechanical fastening using thermal break tubes and metal screws, and the 10 cm overlap is torched by gas flame. The installation resources are included in this study.

PRODUCT USE AND MAINTENANCE (B1-B7)

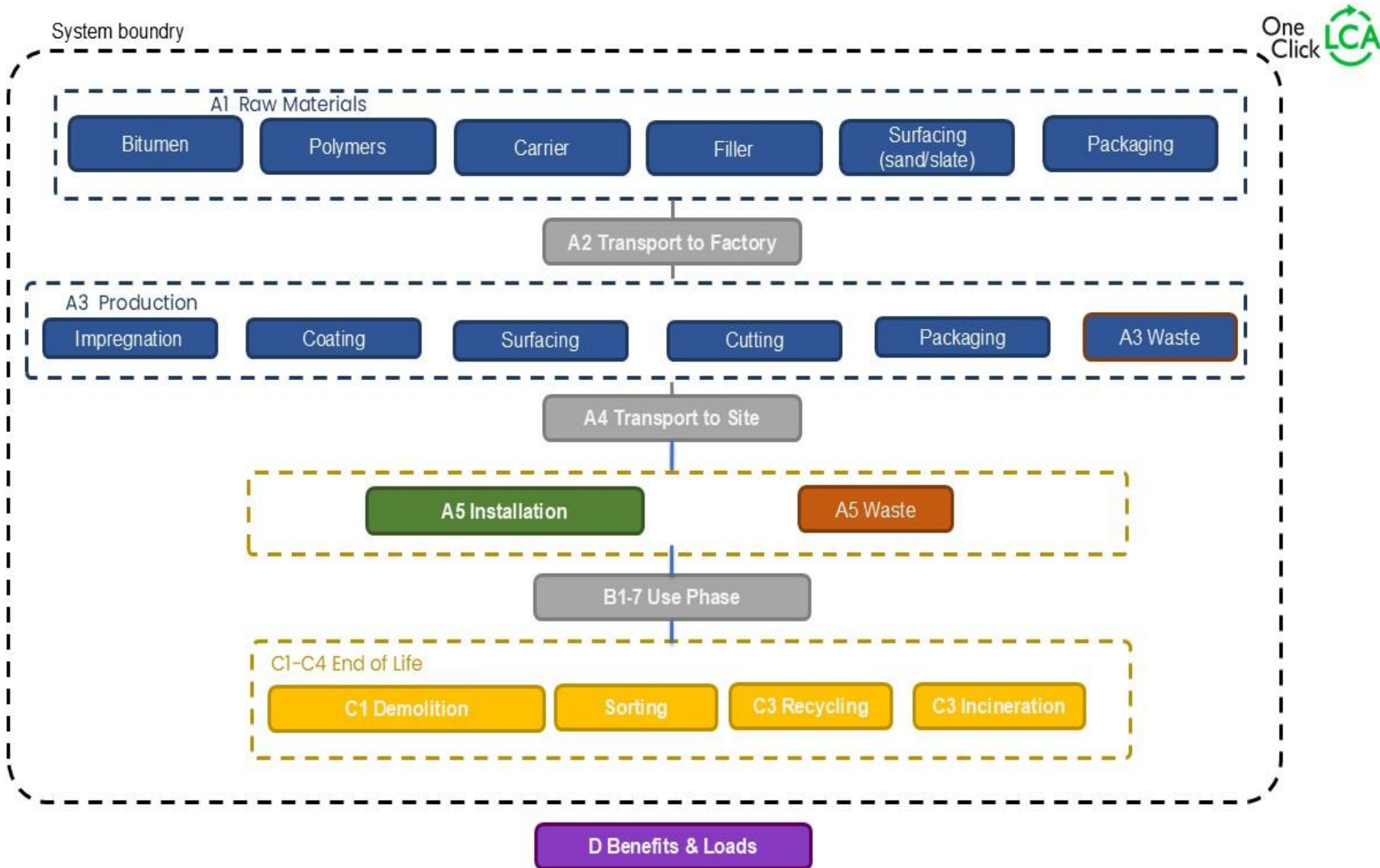
During the use stage (B1-B7) there are no environmental impacts caused by the product. There are no emissions and no consumption of raw materials. There is no need for repair, replacement or renovation during the use of the product, under standard conditions. The product does not consume energy or water during its life. The maintenance activities are limited to annual cleaning activities (e.g. cleaning of water outlets) by human resources, which may be omitted from the calculations.

Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)

At the end-of-life, in the demolition phase 95% of the waste is assumed to be collected as separate waste for recycling in asphalt mix for roads. The remaining 5% is considered to be incinerated. The consumption of energy for disassembling at the end-of-life is assumed to be 0,05 kWh/m² (C1). The bitumen sheet is delivered to the nearest construction waste treatment plant (C2), which is approximately 50 km. At the waste treatment plant, waste that can be reused, recycled or recovered for energy is separated and diverted for further use (C3). Unusable materials are disposed of by incineration (C4). Due to the recycling potential of bitumen sheets, it can be used as raw material for asphalt mix. Recycling bitumen sheets avoids the use of virgin raw material, and the heat recovered from the combustion of bitumen roofing replaces the use of fossil fuels in energy production (D).

LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product’s manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator for EPD Hub V3 and EPD Process Certification v3.2.5. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.10.1/3.11/3.12 and One Click LCA databases as sources of environmental data. Allocation used in Ecoinvent 3.10.1/3.11/3.12 environmental data sources follow the methodology 'allocation, Cut-off, EN 15804+A2'.
